Ms. Netzband mentioned that she will be working with Bill Loveland from the Sherrill Library regarding the Dolly Parton Imagination Library.

Mr. Kinne inquired about reconfiguring the set-up for Board Meetings so that Board Members don't have their backs to the public. This will be considered.

Mr. Adams shared that he felt graduation went well in the auditorium. Ms. McMullen inquired about the possibility of holding graduation in the High School gym, noting that not all students can be seen in the auditorium. Ms. Group noted that the auditorium is air conditioned, so that is the main reason for holding it there. Ms. Pangburn heard from parents that they were pleased with the auditorium location.

Ms. Pangburn shared some praise from a parent for Ms. Coe, an elementary teacher in the district.

Ms. Group handed out School Boards Institute certificates for New School Board Member training to Mr. Kinne and Ms. McMullen.

Ms. Group noted that she will send the board survey as a Google doc and will send a Doodle Poll to schedule the next Board Workshop.
